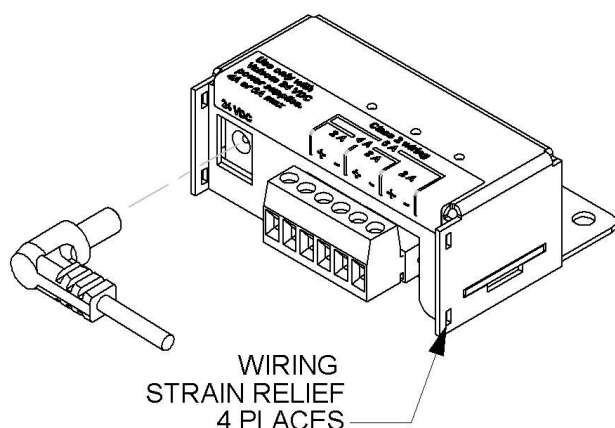

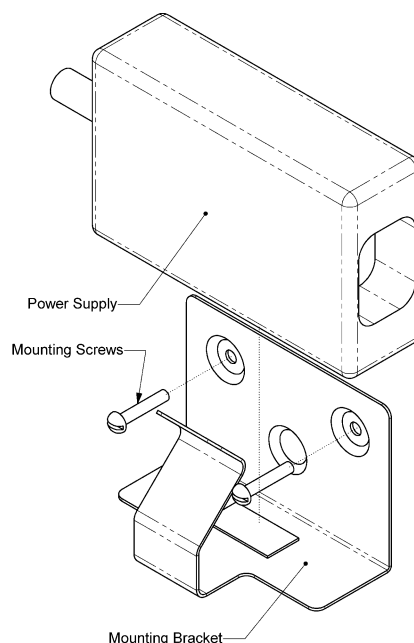
TECHNICAL ASSISTANCE
